**Staff:** Directed by current State of Vermont Staff Coach, Don Haddox. Coach Haddox holds National level

coaching certification from the United States Soccer Federation (USSF), Advanced National level certification from the National Soccer Coaches Association of America (NSCAA), and a Level 1 Goalkeeping Diploma from the NSCAA. He has led Harwood teams to two State Championship appearances as well as two additional final four appearances in his time in Vermont. He is also a head coach in the Vermont Olympic Development Program (ODP) and a Senior Staff Coach with a local premier club. Joining him on staff will be additional nationally licensed coaches, both male and female, as needed to assure the maximum contact hours for each player. Also assisting during the camp will be the very popular Harwood High School soccer teams to ensure a very personal

experience for all young players!
