He has led Harwood teams to three State Championship appearances as well as multiple final four appearances in his time in Vermont. Coach Cort brings with him the experience of a college player, a life-long love of soccer, and a vast wealth of camp experience to ensure your child has the “most fun soccer camp ever” experience. Coach Carlos is the Montpelier HS Boys JV Soccer coach and brings a wealth of coaching and playing experience with him from his native Uruguay. Coach Ally is the JV Girls soccer coach at Harwood as well as being a former HU and Johnson State College standout. I understand that participation in soccer can involve certain risks, including but not limited to, death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, and serious injury to virtually all bones, joints, muscles and internal organs, and that equipment provided for my protection may be inadequate to prevent serious injury. In addition, I understand that participation in sports involves activities incidental thereto, including, but not limited to, travel to and from the site of the activity, participation at sites that may be remote from available medical assistance, and the possible reckless conduct of other participants. I am voluntarily participating in this activity with knowledge of the danger involved and hereby agree to accept any and all risks of property damage, personal injury or death. I further agree to indemnify and hold harmless Highland Soccer Systems, Don Haddox, and all others listed above for any and all claims arising as a result of my participation in this activity or any activities incidental thereto, wherever, whenever, and however the same may occur.

I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of the State of Vermont, and I agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be in the state of Vermont.
